#### Finance Reports

Chair of the Finance Committee, John MacDonald, presented the LVWIB Finance Committee Reports including: Projected Funding Sources for Program Year 2014, Statement of Projected Revenue for the period of June 1, 2014 to June 30, 2015, Statement of Financial Position and Statement of Activities as of January 31, 2015, Accrued Expenses vs. Spending Plan by Accounts for the period ended January 31, 2015 and projected Program Year 2014, Revenues and Spending Plan by Funding Source, July 1, 2014 to June 30, 2015.

## ACTION: Gregg Potter motioned, John Mehler seconded, all approved the Finance reports as presented.

John MacDonald introduced Jeff Dobeck of Buckno Lisicky who reviewed the Lehigh Valley Workforce Investment Board, Inc. Financial and Single Audit Reports, dated June 30, 2014, which resulted in a clean audit with no findings. Jeff Dobeck also presented the IRS Form 990 for Board review.

## **Committee Reports**

### Industry

Larry Wiersch reported that the Industry Committee met February 13, 2015 and was joined by Berks County WIB which provided the Committee on their efforts to address workforce needs in precision machining. Also discussed was PA CareerLink<sup>®</sup> Lehigh Valley becoming a National Occupational Competency Testing Institute (NOCTI) test center.

### Youth Workforce Development Council

Ellen Kingsley reported on the Youth Workforce Development Council which met on February 20, 2015 including challenge of recruiting out-of-school youth, eligibility changes under the Workforce Innovation and Opportunity Act (WIOA), outreach tools and methods, and the need for vendors to meet contracted performance outcomes. An update on CareerFORCE Initiatives was provided including: CareerLinking Academies, statewide Business Education Grant, Bosch Community Fund Grant, Apprenticeship Grant, Easton Jobs Initiative, Jobs1<sup>st</sup> Grant, Federal Reserve Bank, and E2 Summit.

Joe Farrell from EDSI reported that operational performance is on track or exceeding projections and John Haupt presented Fast Facts.

## Public Policy

Vito Gallo reported on the Public Policy Committee which met on February 27, 2015 to discuss Governor's Wolf proposed budget and Acting Labor and Industry Secretary Manderino's recent remarks which mentioned Lehigh Valley Diversified Manufacturing Industry Partnership for best practices. Carol Obando-Derstine reported on Senator Casey's Senate Bill 2788 called the Middle School Technical Education Program Act.
